INSTRUCTIONS TO BE FOLLOWED:

- The staff deployed on duty should remain in proper dress code with name plates displaying their name and designation.
- The duty staff deployed at Langar sites shall report on duty on the day of start of Langar sewa on these sites.
- No kind of leave shall be sanctioned during the Yatra Period.
- Availability of ambulances alongwith driver must be ensured at recognized points.
- > Banners with arrows depicting the Health facilities must be installed prominently at the places where medical aid facilities are being provided.



- The Block Medical Officer Kishtwar / Paddar will properly maintain, supervise the arrangements in their respective areas and maintain liaison with Tehsildar Kishtwar, SDM Paddar, concerned Police Officers, Members of Sanstha and undersigned.
- BMO Paddar will ensure availability of Oxygen Cylinder, Patient Stretchers, patient beds & all other allied items and equipments at all vital Medical Assistance booths required to cater emergencies.
- BMO Paddar will also establish MI rooms at Paddar, Gulabgarh, Massu, Chishoti & Machail.
- > BMO Paddar shall ensure that all medicines and Equipments including Oxygen Cylinders & Oxygen concentrators are in place in each and every Medical Assistance booth enroute
- Medical Superintendent Distt. Hospital Kishtwar will keep one ward fully equipped and ready in Distt. Hospital Kishtwar to meet any eventuality during the Yatra Period.
- > The Teams shall collect medicines from their respective Block HQs well in advance for establishment of Medical Assistance Booths on the due date.
- Disaster Management Plan to be kept ready and in place by Medical Superintendent Distt. Hospital Kishtwar, BMO Kishtwar and BMO Paddar. A copy of this Plan be submitted to this office before 25
- > Apart from this BMO Kishtwar / Paddar can make additional arrangements at the places where they find it necessary without disturbing the above setup/orders.
- > Concerned BMOs shall ensure that proper record of patients checked / referred & Medicines disbursed to patients is maintained at every Medical Assistance Booth falling under their control.
- > BMO Paddar / Kishtwar will keep check on establishment of Medical Camp by private authorities. They will ensure that no private medical camp is established enroute under their jurisdiction without having prior permission from the office of the undersigned.
- > Those employees, who have been deputed to Paddar Block from other Blocks of the District, shall report to BMO Paddar before proceeding further to their place of deployment. Block Medical Officer Paddar shall ensure proper boarding and lodging facility for the employees coming from outside Blocks, especially for those who will be attending duties at Machail Bhawan.
